## **Notices, Agreements, Rules & Policies:**

- 1) Participants must be onsite, in full garb and ready to perform by 9:30AM on Saturday and by 11:30 AM on Sunday for Participant Morning Meeting and Participant Group Photo on Sunday.
- 2) All participants must be available to perform during the entirety of both days of festival, including any afterhours Feast on Saturday night; unless prior arrangements have been made with Festival Management.
- 3) All performing participants must be at Front Gate for Opening Gate Ceremonies/Scenario.
- 4) Participants must appear throughout entire contract days in full garb; shoes are mandatory for all participants, street and stage. It is the responsibility of each participant to provide his/her own garb and accessories necessary to perform contracted job.
- 5) All participants must be on time and perform as scheduled in the program unless otherwise specified by Festival Management.
- 6) All Weapons must be sheathed, and peace bound at all times unless in use during an approved with the stage show or lane scenarios. It is expected that at the end of said shows, all weapons will either be peace bound or stored in restricted access area.
- 7) There is a **strict zero tolerance** for the consumption of alcohol on faire site at any time as well as the use and/or distribution of illegal substances at any time on faire site. Violators will be turned over to the proper authorities for prosecution, all contract monies will be forfeited, and offenders will be permanently banned from all future involvement in any Festival or Event owned, operated, or managed by Williams Entertainment.
- 8) NO SMOKING/NO VAPING OF ANY KIND (tobacco or medical marijuana) AND NO USE OF SMOKELESS TOBACCO OF ANY KIND inside facility nor on ANY part of facility grounds, including parking lot.

- a. If you choose to disobey city ordinance, you **MUST** be 60 feet away from ANY part of the building and doorways AND you **MUST** clean up after yourself (no butts/used medical marijuana joint ends/papers, or spit puddles/used tobacco pouches) left on ground. If you do not clean up after yourself, you will be fined an **ADDITIONAL clean up fee of \$250.00** to cover cost of Host City's fine.
  - b. Leave the area CLEANER than you found it; there will be trash cans available.
- 9) You will be assigned a parking place for your vehicle.
    - a. Parking Passes will be determined based on size of group/distance traveled; carpooling is strongly encouraged to ensure ample parking for patrons.
  - 10) The performer agrees to the use of their personal image and/or likeness, the image and/or likeness by Williams Entertainment Company and/or Grand Lake Renaissance Festival for the use in promotional advertisement across all media outlets.
  - 11) Participants must abide by all rules and policies of Williams Entertainment. These rules and policies are incorporated herein and become part of this agreement between the participant(s) and the Festival.
  - 12) This contract is terminable at will by Williams Entertainment for violations of these rules and policies. Any violation of these rules and policies will result in forfeiture of all contract monies agreed to.
  - 13) Payment will be made at the close of Festival on Sunday, **if possible**. If not possible, payment will be made within ten (10) business days after close of Festival.
  - 14) If for any reason the Festival does not open on any scheduled day, the contract price shall be adjusted on a pro-rated basis. If for any reason a participant does not perform at an agreed upon time and place, the contract shall be adjusted on a pro-rated basis.
  - 15) It is agreed that the above contractor is an independent contractor and as such the contractor is responsible for all and any taxes, including workman's compensation.
  - 16) This contract is a confidential agreement with said participant(s); neither the contracted participant(s) nor Management of Williams Entertainment shall disclose any of its compensatory details to any other party.
